When her owner brought sweet, 13-year-old Akira to Lollypop Farm, she thought it was to say goodbye to her dear friend. She'd loved Akira since she was just a month old, and now her friend had developed several large, painful mammary tumors. Unemployed during the pandemic, her family was struggling and unable to afford the surgery needed. She thought she had run out of options for her sweet companion, and didn't want to see Akira suffer.

Worried that cancer may have spread, Lollypop Farm veterinarians took x-rays. Confirming Akira's lungs were cancer-free, she was cleared for surgery in the Klingenstein Veterinary Clinic. During the procedure, a heavy, 8-inch mass was removed and Akira was given a second chance to live out her life with her family who clearly loved her. Pets like Akira are able to stay with their family thanks to the Lollypop Farm H.O.M.E. (Help & Options for Medical Emergencies) program and animal lovers like you.

152 PETS

received veterinary care that made it possible for them to stay with their families.

14,660 POUNDS

of food and supplies were provided to families to feed their pets.

163 FAMILIES

in crisis were helped through the emergency pet food program. 84 PETS

were temporarily sheltered for families in crisis through our Mary Ellen program.



PERFORMED 8,521 SURGERIES TO HELP PETS IN THE SHELTER AND OUR COMMUNITY.



1,453 feral cats received spay/neuter surgeries, ear-tipping, rabies and vaccinations to prevent distemper. We are here to ensure the health of Rochester's community cat populations and prevent homeless litters.



2,094 cats and dogs received spay/neuter surgeries through S.N.I.P. (our spay/neuter incentive program) that provides low-cost services to qualifying families to help their pets.




When a tumor had grown on Lily's head, your support made it possible for her to receive care at Lollypop Farm's Klingenstein Veterinary Clinic, and a second chance with a new family.

When we first met Big Me he was chained to a tree. It was clear this little mixed-breed had known very little affection in his life. He was suffering from neck pain and was mostly blind. There are some that might have mistaken him as aggressive, but our behavior team saw beyond his rough exterior.

It wasn't long before staff had affectionately renamed him Beanie, but it would be a

long time before Beanie left the shelter.
Beanie would need extensive care and pain management from our veterinary clinic. Beanie required a strict behavior modification plan and patience as he learned to trust. The Adoptions Team was challenged with helping him find the perfect place to call home. It was almost a year before we found Beanie the perfect family.

IT WAS 3 A.M. WHEN HUMANE LAW ENFORCEMENT RECEIVED THE CALL.

After a devastating fire, firefighters on the scene discovered cats living in the home. Nothing could have prepared us for what we would discover. The number of cats in peril seemed endless, some having suffered burns and others smoke inhalation. In just 24 hours, over a hundred cats were removed from what was left of their home, and brought to Lollypop Farm for care.

Our shelter jumped into action making space to care and treat the population. Many required complicated surgeries. Those that were healthy were undersocialized, requiring behavior intervention and carefully placed adoptions. They may have come in as 100 cats from a house fire, but each cat left individually cared for and loved.

NEW WAYS TO C.A.R.E.

In 2021, Lollypop Farm launched a new program to provide Compassionate Aide for Retired Equine or C.A.R.E. Often unrideable and expensive pets to keep, retired equines have significant challenges on the road to adoption. C.A.R.E. allows kind members of the community to take these horses in for long-term foster care and write-off the expenses associated with their upkeep on their taxes. This creative solution breaks down barriers helping homeless horses.

LOLLYPOP FARM MAINTAINS AN SPCA DESIGNATION

AND IS CHARGED WITH INVESTIGATING AND ENFORCING



With no government or agency funding, our Humane Law Enforcement Department depends on individual donations to protect the pets of Monroe, Orleans, Genesee, and Livingston counties.

Lollypop Farm's 5 investigators respond to calls for service and act as ambassadors on behalf of the pets in our community. Through their investigations they often come across situations where there is no intentional harm.

The pet's family either doesn't have the right information or resources to provide appropriate care. In these cases, investigators do their best to help provide what is necessary to keep pets with families who love them whether it's food, access to veterinary care, or information.





It seemed like a normal day at the Country Max in Henrietta when store employees were suddenly informed that customers had heard disturbing noises coming from a self-serve dog wash station. After CCTV recordings showed a man repeatedly punching a German Shepherd mix, employees knew just who to call. Lollypop Farm Humane Law Enforcement investigators identified the suspect. Partnering with Rochester Area Crime Stoppers, Lollypop Farm Humane Law Enforcement located and charged him with overdriving, torturing, and injuring an animal.



3,378 CASES

Programs like Summer Camp and Shelter Helpers emphasize the importance of helping animals and those in need. Campers learned to see beyond stereotypes, creating rat mazes, and interacting with furry friends they may not have previously encountered. Shelter Helpers focuses on learning the importance of working as a community to help those in need.




